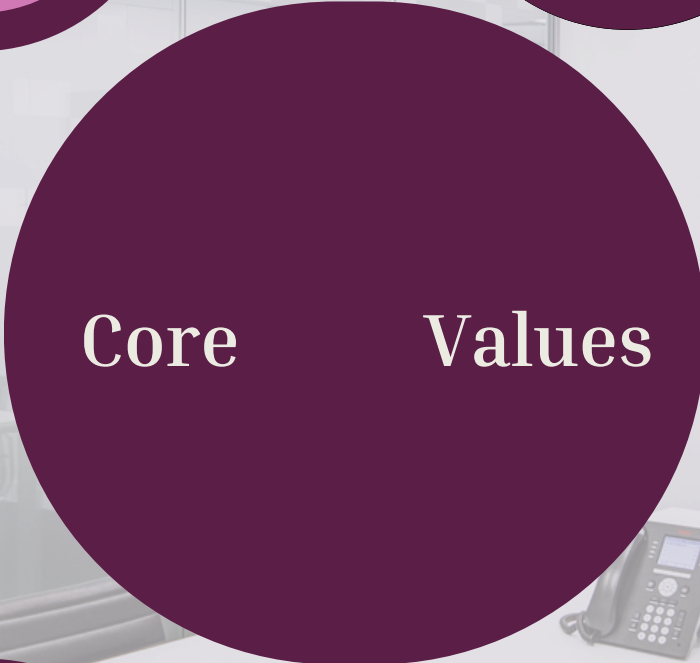

## Contract Administration

Contract administration is one of the core competencies of construction project management which ensures that the construction industry practitioners understand and comply with the terms, conditions and legislative changes related to construction contracts.

## Dispute Management

Adopting dispute resolution methods in construction projects is essential because if the disputes are not managed and resolved properly, it will cause additional costs and time while damaging the contractual relationship between the parties to the contract. Initially, the disagreements between the parties are resolved considering the Conditions of Contract, but if the parties failed to resolve the disputes by themselves, Alternative Dispute Resolution (ADR) methods can be used. Mainly, negotiation, mediation, adjudication and arbitration can be considered as the ADR methods utilized in the construction industry is resolving disputes.
